Hospital Welfare Section:-

It occasionally distributes sweets and fruits to indoor patients. Besides, it arranges ambulance services for poor and deserving patients, organizes health checkup of school children and organizes immunization camps in the rural areas.

St. John Ambulance Association, Fatehabad:

The association was formed on September, 1997 to provide training in first aid and to arrange transport for the patients in hospitals. It is governed by St. John Association Haryana State Branch, Chandigarh and is affiliated to all India St. John Ambulance Association, New Delhi.
